

Cookie Policy

BNP Paribas pays particular attention to your expectations and wishes to nurture your confidence in our company. As regards your personal data, we would like to give you clear information about our policy concerning how the alliwishyou.com website stores and uses cookies in your terminal.

What is a Cookie?

Cookies are small text files that are placed and stored on your computer, your smartphone or any other device optimized for the Internet, when you visit a website. Quite usefully, cookies allow an Internet site to identify you, to log your visit to a given Internet page and thus provide additional services – improving your browsing comfort, making your connections more secure or matching page content with your areas of interest.

The information stored by cookies has a limited validity period. It may concern the web pages you have visited, the ads which you have clicked on, the type of browser you use, the items of information you have entered on a website to avoid repeating them. This information may sometimes be linked to your IP address.

What Types of Cookies do we store?

• Statistics and Audience Cookies:

In order to customize our website to our visitors' requirements, we measure anonymously the number of visits, the number of viewed pages as well as our visitors' activities on the site and their return rate. These cookies enable us to compile traffic analytics and statistics, which we use to improve the contents of our Website based on the success of the different pages based on your visits.

The validity period of BNP Paribas' such cookies is limited to a maximum of 12 months.

• Technical / Operating Cookies:

These are used to save your preferences, your display parameters and devices, whether you have watched the video introduction, the language you use, in order to make your browsing smoother when you return to our website and offer you a rich and immersive digital experience.
